ORDER DIRECTING RESPONSE TO MEDIATION REQUEST

On September 16, 2024, Complainant Ryan Dooley filed a complaint with the Commission against Union Electric Company d/b/a Ameren Missouri. That same day, the Commission issued an *Order Giving Notice of Case Filing, Directing an Answer, and Directing a Staff Investigation*.

On October 14, 2024, Ameren Missouri filed a *Request for Mediation*, pursuant to Commission Rule 20 CSR 4240-2.125(2). Mediation is an informal method of dispute resolution in which the parties voluntarily agree to participate. If mediation is unsuccessful, the case returns to the contested case track. No party relinquishes any rights by agreeing to participate in mediation.

The Commission will order the complainant to respond and state if they agree to mediate the complaint.

THE COMMISSION ORDERS THAT:

1. No later than October 24, 2024, Ryan Dooley shall file a response to Ameren Missouri's mediation request and state whether he agrees to enter into mediation.
2. All other actions in this matter shall cease and all time limitations and deadlines are tolled until further order of the Commission.
3. This order is effective when issued.
