NOTICE OF DISMISSAL

Comes now Unite Private Networks, LLC, (hereinafter "Applicant"), a Missouri limited liability corporation, and pursuant to § 392.410 RSMo 2003, § 392.420-.450 RSMo 2000, § 392.361 RSMo 2000, 4 CSR 240-2.060(1) and (4), and 4 CSR 240-3.510, and hereby notifies the Commission, Staff, and the Office of Public Counsel that Applicant hereby dismisses from its Application its request for a certificate of service authority to provide basic local telecommunications service authority.

1. Applicant no longer seeks certification to provide basic local telecommunications service in the service areas of Southwestern Bell Telephone Company, CenturyTel of Missouri, Spectra Communications, or Sprint Missouri Inc.
2. If Applicant subsequently seeks certification to provide basic local telecommunications service authority in the state of Missouri, it will then file an application therefore.
3. Applicant hereby dismisses its allegations, assertions, and requests for the relief of being granted certification to provide basic local telecommunications service in

the service areas of Southwestern Bell Telephone Company, CenturyTel of Missouri, Spectra Communications, or Sprint Missouri Inc., as set forth in paragraphs 6 and 13, and portions of paragraph 9, 10, and 14, of its September 19, 2005 Application filed herein.

WHEREFORE, Applicant respectfully requests that the Commission grants it certificates of authority to provide interexchange telecommunications services throughout Missouri, and to provide non-basic local or unswitched local telecommunications service throughout Missouri, together with such other and further relief as is necessary or convenient to the relief as set forth above.
