## Motion to Be Excused from Hearing Notice of Availability for Agenda

In addition, should the Commission determine it wants to conduct a verbal explanations at an agenda meeting to consider the Stipulation Respecting Adjustments to Sewer Charges Applicable to Intervenor Four Seasons Racquet and Country Club Condominium Property Owners Association, Inc., the undersigned hereby notifies the Commission that he would not be available for agenda meetings on March 24, March 31 or April 7, 2010.

In support of this Motion and this Notice, Intervenor states as follows:

- 1. On or about October 7, 2009, this rate case proceeding was initiated.
- 2. On or about November 2, 2009, Intervenor was permitted to intervene.

3. On or about November 17, 2009, a procedural schedule was ordered with hearing scheduled for March 29-April 2, 2010.

4. On or about February 22, 2010, Intervenor, Lake Region, and Staff executed and filed a Partial Non-Unanimous Stipulation Respecting Adjustments to Sewer Charges Applicable to Intervenor Four Seasons Racquet and Country Club Condominium Property Owners Association, Inc. (Stipulation). This Stipulation, if approved, resolves the issue and concern for which Intervenor intervened in this proceeding.

On or about March 2, 2010, the Commission entered an Order treating this
Stipulation as a Unanimous Stipulation.

6. Paragraphs17 and 18 of the Stipulation provide that the parties may file written suggestions in support of the Stipulation, or may provide verbal explanations concerning the Stipulation to the Commission at any agenda meeting at which this case is noticed to be considered by the Commission.

7. As the Stipulation resolves Intervenor's interest in this rate case, Intervenor wishes to be excused from the time and expense of having counsel attend and participate in the hearing.

8. If the Commission does determine it wants verbal explanations concerning the Stipulation, Intervenor would like to participate therein.

Wherefore, on the basis of the foregoing, Intervenor Four Seasons Racquet and Country Club Condominium Property Owners Association, Inc. respectfully requests that the Commission grant its request to be excused from attending and participating in the hearing scheduled for March 29 to April 2, 2010, and that the Commission
