Ameren Missouri filed a Compliance Filing, to which the Office of the Public Counsel (OPC) responded March 22, 2023, and again on June 13, 2023, stating that the filing did not comply with Commission Rule 20 CSR 4240-2.135(2). Ameren Missouri responded on March 11, 2024.
