## ORDER GRANTING APPLICATION TO INTERVENE

On September 30, 2024, Union Electric Company d/b/a Ameren Missouri filed the above-referenced rate case. The Commission directed notice and set a deadline for applications to intervene. The Commission received a timely intervention request from Missouri School Boards' Association (MSBA). More than ten days have passed since the application was filed and no one has responded.

After considering the unopposed application to intervene, the Commission finds that the applicant has interests which are different from that of the general public and allowing the applicant to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

### THE COMMISSION ORDERS THAT:

1. The application to intervene filed by MSBA is granted.
2. This order shall be effective when issued.
