On April 25, 2024, The Empire District Electric Company d/b/a Liberty filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file an application with the Commission seeking a waiver from Commission Rule 20 CSR 4240-13.050(9) and possibly other provisions of 20 CSR 4240-13 related to the full utilization of Advanced Metering infrastructure (AMI). The Commission's notice rule provides that if the application is not filed within 180 days the noticed case shall close.

More than 180 days have passed since Liberty filed its notice and by terms of the regulation, File No. EE-2024-0318 has closed.
