NOTICE THAT FILE HAS CLOSED

On April 25, 2024, The Empire District Electric Company d/b/a Liberty filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file a Missouri Energy Efficiency Investment Act (MEEIA) application pursuant to Section 393.1075, RSMo, and Commission Rules 20 CSR 4240-20.093 and 20.094 for authority regarding demand-side programs and a Demand-Side Programs Investment Mechanism (DSIM) that will include cost recovery of demand-side program costs, recovery of a portion of the net shared benefits, lost revenues, and an incentive mechanism. The Commission's notice rule provides that if the application is not filed within 180 days the noticed case shall close.

More than 180 days have passed since Liberty filed its notice and by terms of the regulation, File No. EO-2024-0317 has closed.¹
