On August 23, 2019, the Commission stayed this proceeding and ordered the parties to file a status report or a motion to end the stay no later than November 4, 2019. On November 4, 2019, Staff filed a status report on behalf of the parties. Staff states that it has filed a draft rule in File No. AW-2018-0394, which may change the Affiliate Transactions Rule, and influence this matter. Public Counsel has proposed a procedural process in File No. AW-2018-0394, running through the end of February 2020.

The Commission will order the parties to file another status report.

### THE COMMISSION ORDERS THAT:

1. The parties shall file a status report no later than January 31, 2020.
2. This order is effective when issued.

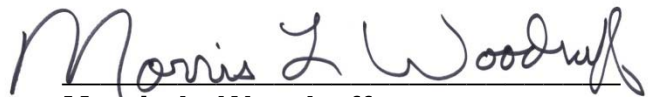
