The Commission opened this file on July 11, 2018, to assist its Staff in its consideration of the writing and rewriting of new and existing rules regarding affiliate transactions and HVAC affiliate transactions. At the direction of the Commission, Staff filed a draft rule on September 16, 2019. Interested stakeholders have asked that the draft rule be given additional informal consideration within this working case. On November 7, 2019, Staff filed a response indicating its agreement.

Staff asks the Commission to allow interested stakeholders thirty days to file comments regarding Staff's draft rules or to propose additional changes to those draft rules. The Commission will do so.

1. Any stakeholder wishing to respond to Staff's draft rules or wishing to propose additional changes to those draft rules shall do so by December 9, 2019.

2. This order shall be effective when issued.


