ORDER OF DISMISSAL

On April 19, 2019, Cordney Jack Travis filed a complaint against Missouri-American Water Company. On November 7, Mr. Travis and Missouri-American Water Company jointly filed a pleading stating the parties have reached a mutually acceptable settlement, and request that the Commission dismiss the complaint, with prejudice.

Commission Rule 20 CSR 4240-2.116(1) states that a complainant may dismiss a complaint only by order of the Commission after prepared testimony or oral evidence has been offered. Prepared testimony was submitted. The Commission concludes that the request to dismiss the complaint is reasonable and will grant that request.

THE COMMISSION ORDERS THAT:

1. The complaint filed by Cordney Jack Travis on April 19, 2019, is dismissed.
2. This order will be effective on December 12, 2019.
3. This case shall be closed on December 13, 2019.
