# **ORDER SETTING PROCEDURAL CONFERENCE**

On June 3, 2019, the Commission Staff submitted a notice that it had begun the prudence review of Union Electric Company d/b/a Ameren Missouri's Missouri Energy Efficiency Investment Act (MEEIA) Cycle 2 energy efficiency programs. On October 30, 2019, Staff filed its report for that prudence review recommending a total disallowance of \$194,451. On November 7, 2019, Ameren Missouri filed a request for hearing.

Ameren Missouri's request for hearing indicated that it was requesting a hearing to preserve its rights under Commission rule 20 CSR 4240-20.093(11)(B), but that it is continuing to have discussions with Staff regarding resolution of the issues. Ameren Missouri requested that the Commission set a scheduling conference within the next 60 days for the purpose of discussing settlement or a proposed procedural schedule. The Commission will set a procedural conference.
