ORDER SETTING PREHEARING CONFERENCE

On September 19, 2019, Dora M. Middleton filed a complaint against Union Electric Company, d/b/a Ameren Missouri. Thereafter, the Commission ordered its Staff to investigate and file a report. Staff filed its report on November 4, 2019.

Having received the complaint, an answer from Union Electric Company, d/b/a Ameren Missouri, and Staff's report, this matter is ready to be set for hearing. In order to discuss a procedural schedule and *possible settlement or mediation* of this matter, the Commission will set a prehearing conference. For their convenience, the parties may appear by telephone as set out below.

THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference to be held on November 25, 2019, at 10:00 a.m. **Failure to appear at the conference without being excused may result in dismissal of the complaint in accordance with Commission Rule 20 CSR 4240-2.090(5).**

2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs an accommodation to participate in the conference or hearing shall contact the Commission, not later than the day before the conference. Such contact shall be through the Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711.

4. This order shall be effective when issued.


