ORDER GRANTING CONTINUANCE

On November 18, 2019, the Commission issued an order setting a prehearing conference in this matter for November 25, 2019. On November 20, 2019, Union Electric Company d/b/a Ameren Missouri filed a *Motion for Continuance*, stating that its counsel would be unavailable on November 25, 2019, and requesting that the procedural conference be re-scheduled for December 2, 2019, or after. The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Union Electric Company d/b/a Ameren Missouri's *Motion for Continuance* is granted. The procedural conference previously scheduled for November 25, 2019, is canceled.

2. A procedural conference shall be held on December 2, 2019, beginning at 10:00 a.m., in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards


