# STAFF RECOMMENDATION TO APPROVE TRUE-UP FILING

**COMES NOW**, the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and for its Staff Recommendation to Approve True-Up Filing respectfully states:

- 1. On October 1, 2024,¹ Empire Electric Company d/b/a Liberty ("Liberty" or "Company") filed with the Missouri Public Service Commission ("Commission") its true-up filing for Accumulation Period 30 ("AP30"), which includes the time period March 1, 2023, through August 31, 2023, followed by Recovery Period 30 ("RP30"), which includes the billing months from December 1, 2023, through May 31, 2024, under the provisions of its Fuel Adjustment Clause ("FAC") tariff sheets and 20 CSR 4240-20.090(9). Liberty's filing is supported by the direct testimony and supporting schedules of Monica K. Gloodt, Analyst in the Rates and Regulatory Affairs Depart for Liberty's Central Region.
- 2. Commission Rule 20 CSR 4240-20.090(9)(D) requires the Commission's Staff to examine and analyze the information Liberty has submitted. Commission Rule 20 CSR 4240-20.090 provides a 60-day timeline for resolution of these rate adjustment mechanism proceedings. The Commission ordered Staff to file its Report and Recommendation no later than October 31, 2024.

- 3. As explained in Staff's Memorandum, attached hereto as Appendix A and incorporated herein by reference, Staff recommends the Commission approve Liberty's true-up filing.
- 4. The true-up amount of \$462,330 identified in Liberty's filing is the result of an under-collection of the Fuel and Purchased Power Adjustment ("FPA') for AP30 during RP30.
- 5. Staff reviewed and analyzed the direct testimony, supporting schedules and work papers of Liberty and witness Monica K. Gloodt. Staff also reviewed Liberty's monthly interest calculations. Staff agrees with the Company's filings.
- 6. Based on its examination and analysis of information Liberty filed and submitted in this case, Staff recommends the Commission approve Liberty's RP30 true-up filing for the billing months of December 1, 2023, through May 31, 2024, during which Liberty under-collected \$462,330 from its customers, for inclusion in the calculation of the FPA amount in Liberty's AP32 adjustment filing in file No. ER-2025-0125.
- 7. Staff verified that Liberty filed its 2023 annual report and is not delinquent on any assessment. Liberty is current on the submission of its Surveillance Monitoring reports, as required by 20 CSR 4240-20.090(6), and its monthly reports, as required by 20 CSR 4240-20.090(5). Staff is not aware of any other matter before the Commission that affects or is affected by this filing, except File No. ER-2025-0125, as noted herein.

WHEREFORE, Staff submits its analysis and recommends that the Commission approve Liberty's RP30 true-up filing for the billing months of December 1, 2023,

through May 31, 2024, with a total True-Up Amount for RP30 as set out in the body of this pleading.

On October 1, 2024, The Empire District Electric Company, d/b/a Liberty (hereafter "Liberty" or "Company") filed with the Missouri Public Service Commission ("Commission"), in the form of direct testimony and supporting schedules of Liberty witness Monica K. Gloodt, its thirtieth true-up filing under the provisions of 20 CSR 4240-20.090(9).

Accumulation Period 30 ("AP30") includes the time period March 1, 2023, through August 31, 2023, and is followed by Recovery Period 30 ("RP30"), which includes the billing months of December 1, 2023, through May 31, 2024. The true-up amount of \$462,330 identified in this filing is the result of an under-collection of the Fuel and Purchased Power Adjustment ("FPA") amount for AP30 during RP30.

The true-up amount of \$462,330 for RP30 is included in the preliminary calculation of the Fuel and Purchased Power ("FPA") amount included in Liberty's Accumulation Period 32 ("AP32") adjustment filing, also filed on October 1, 2024, in File No. ER-2025-0125, which Liberty filed in compliance with its FAC.<sup>1</sup>

<u>TRUE-UP OF FPA</u>: In conjunction with an adjustment to its FAR, the Company will make a true-up filing with an adjustment to its FAC on the first Filing Date that occurs after completion of each Recovery Period. The true-up adjustment shall be the difference between the FPA revenues billed and the FPA revenues authorized for collection during the true-up recovery period, i.e. the true-up adjustment. Any true-up adjustments or refunds shall be reflected in item T above and shall include interest calculated as provided for in item I above.

Gloodt, the supporting schedules and work papers Liberty provided with its true-up filing in this case, and the monthly information Liberty has submitted to the Commission. Staff also reviewed and agrees with Liberty's monthly interest calculations for RP30.

Based on its examination and analysis of information Liberty filed and submitted in this case, Staff recommends the Commission approve Liberty's RP30 true-up filing for the billing months December 1, 2023 through May 31, 2024, during which Liberty under-collected \$462,330 from its customers for inclusion in the calculation of the FPA amount in Liberty's AP32 adjustment filing in File No. ER-2025-0125.
