On November 3, 2023, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc., d/b/a Evergy Missouri West (collectively referred to as “Evergy”) filed their 2024 Triennial Integrated Resource Plans. Thereafter, the Staff of the Commission and various intervenors filed responses and concerns. Commission Rule 20 CSR 4240-22.080(9) required responses or an agreement to remedy the concerns be filed by October 28, 2024. On October 24, 2024, Evergy with the acquiescence of the other parties, requested an extension of time until November 4, 2024, in which to file an agreement of the parties. The Commission will grant the request for an extension.

1. An extension to file an agreement of the parties is granted. The agreement of the parties is due no later than November 4, 2024.
