**ORDER DENYING APPLICATION FOR REHEARING**

On September 12, 2024, the Commission granted the Commission’s Staff’s Motion to Dismiss and dismissed the complaint by order effective October 15, 2024. On September 17, 2024, the Complainant filed an Application for Rehearing. Thereafter, Complainant filed additional documents, which were not relevant to the application for rehearing.

Section 386.500.1, RSMo 2016, states that the Commission shall grant an application for rehearing if “in its judgment sufficient reason therefor be made to appear.” In the judgment of the Commission, the application for rehearing does not demonstrate sufficient reason to rehear the matter.

If the Complainant wishes to appeal the Commission’s decision, they must file a notice of appeal within thirty days of the effective date of this order in the appropriate appellate court in accordance with Section 386.510, RSMo.

The Commission will deny the application for rehearing.

1. Complainant's application for rehearing is denied.
2. This order shall be effective when issued.

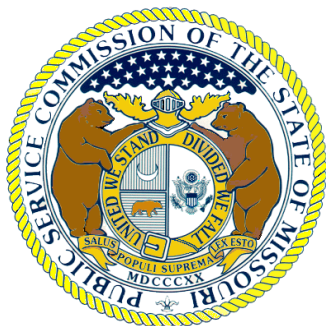
