Union Electric Company d/b/a Ameren Missouri filed a proposed tariff sheet, Tariff No. JG-2025-0058, reflecting changes in its Purchased Gas Adjustment ("PGA"). Those changes are a result of estimated changes in the cost of natural gas and as a result of changes in its Actual Cost Adjustment ("ACA") factors. The proposed tariff sheet has a November 1, 2024, effective date.

The change on the Total PGA rate applicable to Ameren Missouri's service areas will decrease to 60.38¢/Ccf from 60.46¢/Ccf for firm sales customers. The interruptible sales customers' PGA will decrease to 39.09¢/Ccf from 46.46¢/Ccf. The transportation PGA will remain unchanged at 0.00¢/Ccf.

The Staff of the Commission ("Staff") filed its verified recommendation on October 23, 2024. Staff recommended approving the tariff on an interim basis, subject to refund, pending final decisions with regard to the Actual Cost Adjustment (ACA) account balance in File No. GR-2023-0392. The Procurement Analysis Department of Staff stated it will review Ameren Missouri's ACA filing and requests permission to submit its results and recommendations on or before December 15, 2025.

The Commission has reviewed the proposed tariff sheet and Staff's recommendation. Based on the verified filings, the Commission independently finds that the proposed tariff sheet conforms to Ameren Missouri's Commission-approved PGA Clause. In addition, because Ameren Missouri's PGA clause allows for PGA change filings to take effect on ten-days' notice, good cause has been shown pursuant to Section 393.140(11), RSMo 2016, to permit the tariff sheets and this order to become effective on less than 30-days' notice. The Commission concludes the proposed tariff sheets should be approved to become effective on November 1, 2024, on an interim basis, subject to refund, pending final Commission decision in this file and File No.

GR-2023-0392.

THE COMMISSION ORDERS THAT:

1. The tariff assigned Tracking No. JG-2025-0058 is approved, on an interim basis and subject to refund, to become effective on November 1, 2024.

2. Staff shall submit its results and recommendations regarding the information included in this ACA filing on or before December 15, 2025.

3. This order shall become effective on November 1, 2024.
