ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION

On November 21, 2019, Missouri-American Water Company filed a revised ISRS tariff sheet with an effective date of December 21, 2019, and a *Motion for Expedited Treatment* with the Missouri Public Service Commission. Missouri-American requests expedited approval of a tariff in compliance with the Commission’s Report and Order issued in this case on November 21, 2019, and requests the tariff be allowed to take effect for service rendered on and after December 7, 2019, or as soon thereafter as is reasonable.

The Commission will direct its Staff to review and file a recommendation regarding Missouri-American’s request for expedited approval of a revised tariff.

THE COMMISSION ORDERS THAT:

1. No later than December 3, 2019, the Staff of the Commission shall file its recommendation regarding Missouri-American Water Company’s request for expedited approval of a revised tariff, including a statement explaining the need to effect the tariff change on December 7, 2019.

2. Any other entity wishing to comment on Missouri-American Water Company's request for expedited approval of a revised tariff sheet shall do so no later than December 3, 2019.

3. This order shall be effective when issued.


