ORDER DIRECTING FILING

On July 31, 2019,¹ the Commission issued its *Report and Order Approving Third Territorial Agreement*. Its effective date was August 30. The order approved the territorial agreement and ordered The Empire District Electric Company (Empire) to file revised tariff sheets to reflect the territorial agreement. On November 22, Empire filed proposed tariff sheets:

P.S.C. Mo. No. 5, Sec. B. Original Sheet No. 20b; and
P.S.C. Mo. No. 5, Sec. B, Original Sheet No. 20c.

Each of the tariff sheets bears an issue date of November 22 and a proposed effective date of December 22. The Commission will order the Staff of the Missouri Public Service Commission to file a recommendation on the tariff sheets. The Commission will also allow any party who so wishes to file an objection or response to the tariff sheets or to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a recommendation on the tariff sheets, Tracking No. YE-2020-0089, no later than December 5, 2019.
2. Any party wishing to object or otherwise respond to the tariff sheets or to Staff's recommendation shall do so no later than December 10, 2019.
3. This order will be effective when issued.


