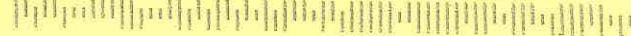

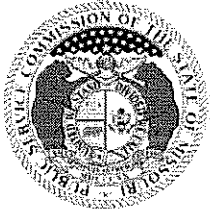

3. The Commission's Public Information Office shall make this order available to the news media serving the service area and to the members of the General Assembly representing the service area.




