## ORDER DIRECTING NOTICE, ESTABLISHING INTERVENTION DEADLINE, AND DIRECTING FILING OF STAFF RECOMMENDATION

On November 22, 2019, Union Electric Company d/b/a Ameren Missouri filed a tariff to adjust the rates of its Energy Efficiency Investment Charge. Ameren Missouri's tariff sheet bears a January 21, 2020 effective date. Commission rule 20 CSR 4240-20.093(4), requires the Commission's Staff perform an examination of the information provided by Ameren Missouri and determine if the proposed adjustments are in accordance with Section 393.1075, RSMo, and applicable regulations. Pursuant to 4 CSR 240-20.093(4)(B), Staff has thirty days to submit its recommendation and the Commission has sixty days to act on Ameren Missouri's filing.

Commission rule 20 CSR 4240-20.093(15)(A) provides that the parties to Ameren Missouri's previous case where a demand-side program was approved "shall have the right to be a party to any subsequent related periodic rate adjustment proceeding without the necessity of applying to the [C]ommission for intervention; however, such person or entity shall file a notice of intention to participate within the intervention period." Thus, the parties to Ameren Missouri's MEEIA File No. EO-2018-0211 may become parties to this proceeding by filing a notice as set out below. The Commission will also establish a deadline for the filing of applications to intervene and direct its Data Center to serve a copy of this order upon the county commission of each county in Ameren Missouri's electric service area and on the corresponding governing body of the City of St. Louis. In addition, the Commission's Public Information Office shall make notice of this order available to the media serving Ameren Missouri's electric service area and to the members of the Missouri General Assembly representing the residents of Ameren Missouri's electric service area.

#### THE COMMISSION ORDERS THAT:

1. Any party to File No. EO-2018-0211 shall be a party to this by filing a notice of intention to participate no later than December 10, 2019.

2. Any applications to intervene shall be filed no later than December 10, 2019.

3. The Commission's Data Center shall serve a copy of this order upon each of the parties to File No. EO-2018-0211.

4. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the electric service territory of Ameren Missouri and upon the corresponding governing body of the City of St. Louis.

5. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the electric service area of Ameren Missouri and to the news media serving the residents of the electric service territory of Ameren Missouri.

6. The Commission's Staff shall file its recommendation no later than December 22, 2019.
