The Commission issued its Order Approving Tariff on November 21, 2019. The tariff will become effective on December 4, 2019. The Commission issues this order to correct an error in that order. The second paragraph of that order describes the change in the total purchased gas adjustment (PGA) factor for The Empire District Gas Company's Northwest System as a "decrease." The order should have said the change for the Northwest System was an "increase." The numbers in the order are correct. Therefore, the Commission will correct this error.

THE COMMISSION ORDERS THAT:

1. The second paragraph of the Order Approving Tariff is corrected to state that the purchased gas adjustment factor for the Northwest System is increased.
2. This order shall be effective when issued.
