ORDER DIRECTING STAFF RECOMMENDATION

On November 15, 2019, Union Electric Company d/b/a Ameren Missouri filed a request to revise its technical resource manual and deemed savings table. Ameren Missouri also included a motion for expedited treatment requesting that the Commission approve the changes to be effective January 1, 2020. The Commission will direct its Staff to file a recommendation regarding the request.

THE COMMISSION ORDERS THAT:

1. No later than December 6, 2019, the Staff of the Missouri Public Service Commission shall file either a recommendation or a status report stating when it expects to file a recommendation regarding Union Electric Company d/b/a Ameren Missouri's request to revise its technical resource manual and deemed savings table.
2. Any other responses to Union Electric Company d/b/a Ameren Missouri's request to revise its technical resource manual and deemed savings table shall be filed no later than December 6, 2019.
3. This order is effective when issued.


