ORDER GRANTING APPLICATION TO INTERVENE

On October 28, 2019, Union Electric Company d/b/a Ameren Missouri filed an application for an Accounting Authority Order that would allow it to defer and amortize certain Callaway Energy Center refueling outage costs. On November 13, 2019, Midwest Energy Consumers Group filed an application to intervene. Commission rule 20 CSR 4240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission. Ten days have elapsed, and no party has objected to the application to intervene. The application satisfies the requirements of Commission Rule 20 CSR 4240-2.075 and intervention will be granted.

THE COMMISSION ORDERS THAT:

1. Midwest Energy Consumers Group's application to intervene is granted.

2. This order is effective when issued.
