**ORDER RECOGNIZING NAME CHANGE**

Effective Date: January 1, 2020

Fidelity Telephone Company submitted a letter dated October 29, 2019, advising that it has changed its name to Fidelity Telephone, LLC, d/b/a Fidelity Communications. The Commission’s Staff filed a recommendation on November 13, 2019, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change. The Commission will do so.<sup>1</sup>

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes the name change of Fidelity Telephone Company to Fidelity Telephone, LLC d/b/a Fidelity Communications.
2. This order shall be effective on January 1, 2020.


