ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, AND DIRECTING STAFF FILING

On November 25, 2019, Liberty Utilities (Missouri Water) LLC (Liberty Utilities) filed an application with the Missouri Public Service Commission requesting a Certificate of Convenience and Necessity (CCN) to install, own, acquire, construct, operate, control, manage, and maintain a sewer system in Cape Girardeau County, Missouri, as an addition to Liberty Utilities' existing service territories.

The requested CCN would allow the Liberty Utilities to provide wastewater treatment and collection system operation and maintenance to 110 customers currently served by an unregulated sewer system owned and operated by Cape Land & Development LLC in the Savers Farm subdivision. There will be no need to install new facilities or for construction by Liberty Utilities, as the sewer system has already been constructed. Liberty Utilities will not require any franchises or permits from municipalities, counties, or other authorities.

The Commission will direct notice be given and set a deadline for intervention requests. The Commission will also direct its Staff to file a recommendation on its review of Liberty Utilities' application.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the County Commission of Cape Girardeau County, Missouri, and to the Missouri Department of Natural Resources.
2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the General Assembly representing Cape Girardeau County, Missouri, and to the media serving Cape Girardeau County, Missouri.
3. Any person or entity wishing to intervene shall file an application to intervene no later than January 2, 2020. Such application shall be filed in the Commission's Electronic Filing Information System.
4. The Commission's Staff shall file either a status report or a recommendation on, Liberty Utilities (Missouri Waters) LLC's application no later than January 17, 2020.
5. This order is effective when issued.
