ORDER DIRECTING NOTICE, ESTABLISHING INTERVENTION DATE, AND DIRECTING FILING OF STAFF RECOMMENDATION

Issue Date: December 3, 2019

On December 2, 2019, Evergy Missouri West, Inc. (formerly known as KCP&L Greater Missouri Operations Company), filed a tariff, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism Rider. The tariff sheets bear an effective date of February 1, 2020. Commission rule 20 CSR 4240-20.093(4) requires the Commission's Staff to examine and analyze the information Evergy Missouri West has filed and to submit a recommendation no later than 30 days after Evergy Missouri West filed its tariff revision. The Commission has sixty days to act on Evergy Missouri Metro's filing.

Commission rule 20 CSR 4240-20.093(15)(A) provides that the parties to Evergy Missouri West's previous case where a demand-side program was approved "shall have the right to be a party to any subsequent related periodic rate adjustment proceeding without the necessity of applying to the [C]ommission for intervention; however, such person or entity shall file a notice of intention to participate within the intervention period." Thus, the parties to Evergy Missouri West's File No. EO-2015-0241 may become parties to this proceeding by filing a notice as set out below. The Commission will also establish a deadline for the filing of applications to intervene and direct its Data Center to serve a copy of this order upon the county commission of each county in Evergy Missouri West's electric service area. In addition, the Commission's Public Information Office shall make notice of this order available to the media serving Evergy Missouri West's electric service area and to the members of the Missouri General Assembly representing the residents of Evergy Missouri West's electric service area.

THE COMMISSION ORDERS THAT:

1. Any party to File No. EO-2015-0241 shall be a party to this by filing a notice of intention to participate no later than December 13, 2019.

2. Any applications to intervene shall be filed no later than December 13, 2019.

3. The Commission's Data Center shall serve a copy of this order upon each of the parties to File No. EO-2015-0241.

4. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the electric service territory of Evergy Missouri West, Inc.

5. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the electric service area of Evergy Missouri West, Inc., and to the news media serving the residents of the electric service territory of Evergy Missouri West, Inc.

6. The Commission's Staff shall file its recommendation no later than January 1, 2020.
