On November 18, 2019, the Staff of the Commission filed its Motion to Suspend Tariff Sheets and Open New Docket. Missouri-American Water Company's tariff could change how often St. Louis County fire protection customers are billed.¹ Thus, Staff believed the tariff may be of interest to other parties. Staff stated that it would conduct its review on the tariff as quickly as practically possible. The Commission took no action on Staff's motion, and the tariff has not been suspended.

On November 22, the Staff of the Commission then recommended that the Commission approve the tariff. Staff stated that the proposed tariff would allow St. Louis County customers the option of being billed monthly or annually.

On November 25, the Commission directed any responses to Staff Recommendation to be filed no later than November 29. The Commission received no responses.
