## NOTICE OF DEFICIENCY

On December 4, 2019, CoBridge Telecom, LLC (CoBridge Telecom) filed a Request for Cancellation of the certificate of service authority. CoBridge Telecom's request was not complete in that the filer failed to provide information regarding which registrations and/or certificates are to be cancelled as required in 20 CSR 4240-28.011(3). CoBridge Telecom is registered as both an IVoIP provider and as a video provider, and needs to inform the Commission which registration is to be cancelled

The Commission will not take action on this request until this deficiency is corrected. The Commission will leave the file open until December 28, 2019, to allow CoBridge Telecom to correct the deficiency. If no response is filed by that time, the Commission will reject the request and close the file.
