On December 4, 2019, CoBridge Telecom, LLC (CoBridge Telecom) notified the Commission that the company no longer wished to be registered as an IVolP provider in Missouri.

The Commission granted CoBridge Telecom's registration to provide IVolP services in the State of Missouri in File Number DA-2012-0087.

The Commission will direct its Staff to review the request and file a recommendation regarding the cancellation of CoBridge Telecom's IVolP registration.

THE COMMISSION ORDERS THAT:

1. No later than December 25, 2019, the Staff of the Missouri Public Service Commission shall file a recommendation regarding CoBridge Telecom's request to cancel its IVolP registration.
2. This order shall be effective when issued.
