## ORDER GRANTING REQUESTS

On November 18, 2019,<sup>1</sup> the Commission issued its *Order Continuing Evidentiary Hearing and Amending Procedural Schedule*. On November 25, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a *Request for Leave to Amend its Original Application and Amended Application* (Request for Leave). On November 26, the Commission issued its order that all objections and responses to Ameren Missouri's Request for Leave be filed no later than 9 a.m. on November 27.

On November 26, acknowledging the Commission's order of that date, Ameren Missouri, the Commission's Staff, and the Office of Public Counsel filed a *Joint Request for Slight Modification of Procedural Schedule* (Joint Request). On November 27, the Commission issued its order that objections and responses to the Joint Request be filed no later than December 2. No party has objected to the Request for Leave or Joint Request. The Commission will grant both requests.

**THE COMMISSION ORDERS THAT:**

1. Ameren Missouri's *Request for Leave to Amend its Original Application and Amended Application* is sustained. The amended application is deemed filed on December 5, 2019.

2. The parties' *Joint Request for Slight Modification of Procedural Schedule* is sustained. Rebuttal Testimony and any Filing Regarding Interpretation of Sections 393.1665 and/or 393.170, RSMo, for the Requested CCNs by Parties other than the Company shall be filed no later than December 12, 2019. Ameren Missouri, the Commission Staff, and the Office of Public Counsel shall respond to all data requests no later than five business days after a request. Otherwise, the Commission's Order of November 18, 2019, *Continuing Evidentiary Hearing and Amending Procedural Schedule* shall remain in effect.

3. This order shall be effective when issued.
