Issue Date: December 5, 2019 Effective Date: December 5, 2019 On December 3, 2019, the Commission issued an order approving a stipulation and agreement and authorizing the filing of tariffs in compliance with that stipulation and agreement. On December 4, 2019, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (f/k/a KCP&L Greater Missouri Operations Company) filed compliance tariffs bearing an effective date of January 3, 2020. Evergy Missouri West also filed a motion for an expedited effective date allowing the tariffs to become effective on January 1, 2020. The Commission will direct its Staff to file a recommendation regarding the tariff and will set a deadline for the filing of responses to the compliance tariffs or the motion for expedited treatment.
