**ORDER GRANTING ADDITIONAL TIME
TO FILE ANSWER TO COMPLAINT**

On April 16, 2024,¹ the Staff of the Commission (Staff) filed a complaint against Spire Missouri Inc. d/b/a Spire alleging violation of certain sections of the Commission’s gas safety rules. The Commission directed Spire to file an answer to the complaint by May 23.

Subsequently, on five separate occasions, Spire requested extensions to the deadline to file its answer to the complaint. In each instance, the request stated that Staff had no objection to an extension of the deadline. The Commission granted the extensions, most recently directing Spire to file an answer or status report no later than October 31.

On October 31, Spire filed a *Request for Time to File Answer*, stating that, while Spire and Staff continue to work towards a resolution, it is now appropriate for Spire to

file its answer to the complaint. As with Spire's previous requests, Staff does not object to Spire's current request.

The Commission will grant Spire's request.

THE COMMISSION ORDERS THAT:

1. Spire's request for time to file an answer to Staff's complaint is granted.
2. Spire shall file an answer to the complaint no later than November 15, 2024.
3. This order shall be effective when issued.
