ORDER DISMISSING CASE

Issue Date: November 1, 2024

Effective Date: December 1, 2024

On September 26, 2024, Marquette Lumumba Mugabe Bey filed a complaint against Spire Missouri. The Commission issued a Notice of Deficiency on October 16, 2024. That Notice stated that unless the complainant stated, no later than October 30, 2024, in a clear and concise, manner an alleged violation of a tariff, statute, rule, order, or decision with the Commission’s jurisdiction, the Commission may dismiss the complaint.

Mr. Bey filed a Request for Rehearing on October 31, 2024. The Request was untimely, and it did not cure the deficiency. Thus, the Commission will dismiss the complaint.

Under Commission Rule 20 CSR 4240-2.070(14), the Regulatory Law Judge shall cause the parties to be notified that the dismissal of Mr. Bey’s complaint will be final unless an application for rehearing is filed. The application for rehearing must be filed with the Commission before the effective date of this order.

If the Commission denies the application for rehearing, the parties then have 30 days after the denial is issued to file an appeal with the court of appeals. If the Commission grants the application for rehearing, then the Commission will order appropriate actions at that time.

THE COMMISSION ORDERS THAT:

1. The Commission has no jurisdiction over the allegations in the complaint, and therefore dismisses this complaint.
2. If the Complainant wishes to request a rehearing by the Commission, such request must be filed no later than November 30, 2024.
3. This order is effective on December 1, 2024.
