On October 8, 2024, the Commission issued its *Order Directing Evergy to File Substitute Tariff Sheets and Setting Time for Responses*. That order directed the Commission's Staff (Staff) to file a recommendation by October 18, 2024, about whether Evergy's substitute tariff sheets comply with the stipulation and agreement filed by some of the parties in these cases. At Staff's request the filing date for a Staff recommendation was extended to November 1, 2024.

On November 1, 2024, Staff filed another request for a one-week extension of time to file a recommendation. Staff explains that the additional time is to address Staff's concerns with Evergy's proposed tariff sheets.

The Commission will grant the extension request and extend the time for responses to Evergy's tariff sheets.

THE COMMISSION ORDERS THAT:

1. Staff's motion for an extension is granted. Staff shall file its recommendation about Evergy's substitute tariff sheets no later than November 8, 2024.

2. Any other comments about Evergy's substitute tariff sheets shall be filed no later than November 8, 2024.
