## NOTICE REGARDING TARIFFS

Issue Date: December 9, 2019

On November 12, 2019, the Commission issued its Order Recognizing Name Change, in which it recognized that Fidelity Cablevision, Inc., had changed its name to Fidelity Cablevision, LLC d/b/a Fidelity Communications (Fidelity Communications). Fidelity Communications then submitted tariff sheets on November 18, 2019 that adopt previously filed tariffs.<sup>1</sup> Those tariffs effectively adopt tariffs of prior named entities, and they bear an effective December 18, 2019.

On December 5, 2019, the Staff of the Commission recommended that the Commission permit the tariff sheets to take effect. The Commission has received no other responses.

The Commission has reviewed the tariff sheets and Staff's recommendation. The Commission will allow the tariff sheets to take effect.
