On December 9, 2019, Global Strategic Accountants, LLC, filed a request on behalf of Common Point, LLC, to cancel Common Point's certificates of service authority. In File No. LA-2009-0278, the Commission granted Common Point certificates to provide intrastate interexchange and nonswitched local exchange telecommunications services. The Commission will direct its Staff to review the request and file a recommendation regarding the cancellation of Common Point's certificate of service authority.

### THE COMMISSION ORDERS THAT:

1. No later than December 30, 2019, the Staff of the Missouri Public Service Commission shall file with the Commission a recommendation regarding Common Point, LLC's request to cancel its certificates of service authority.
2. This order shall become effective upon issuance.


