**ORDER APPROVING RESRAM TARIFF**

Issue Date: December 11, 2019

Effective Date: January 10, 2020

On September 27, 2019, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) submitted a tariff and accompanying testimony to adjust its renewable energy standard rate adjustment mechanism (RESRAM) pursuant to Section 393.1030, RSMo, and Commission Rule 20 CSR 4240-20.100(6). The submitted tariff bears an effective date of February 20, 2020. The Commission directed notice, set an intervention deadline, and ordered its Staff to file a recommendation. No persons or entities applied to intervene.

The Commission's Staff filed its recommendation on November 26, 2019. Ameren Missouri's total RESRAM expense balance as of July 31, 2019, including interest, was \$6,810,930, which includes \$6,130,807 in solar rebate payments authorized under Section 393.1670 RSMo. The annual RESRAM Revenue Requirement is \$7,234,842, which is actual annualized RESRAM costs from the first accumulation period ending July 31, 2019. Total RESRAM Recoveries are \$14,134,619. Customers using 1,000 kWh per month will see a \$0.44 increase per month. Application of this rate will not exceed the annual rate cap pursuant to Section 393.1655 RSMo. Staff recommends that the

Commission approve Ameren Missouri's RESRAM adjustment tariff to be effective on February 1, 2020.

The Commission has reviewed the proposed tariff sheet and Staff's recommendation. The Commission finds that the proposed tariff sheet conforms to Commission Rule 20 CSR 4240-20.100(6). The Commission concludes that the proposed RESRAM adjustment tariff should be approved to become effective on February 1, 2020.

**THE COMMISSION ORDERS THAT:**

1. The proposed tariff sheet filed on September 27, 2019, by Union Electric Company d/b/a Ameren Missouri, assigned tracking no. YE-2020-0048 and bearing an effective date of February 1, 2020, is approved to be effective on February 1, 2020. The tariff sheet approved is:
