On October 30, 2019, the Missouri Public Service Commission issued a *Report* and *Order* effective November 12, 2019, regarding Spire Missouri Inc.'s applications to change its infrastructure system replacement surcharges. The Office of the Public Counsel and Spire Missouri Inc. filed timely applications for rehearing.
