ORDER DENYING APPLICATIONS FOR REHEARING

On October 30, 2019, the Missouri Public Service Commission issued a *Report and Order* effective November 12, 2019, regarding Spire Missouri Inc.'s applications to change its infrastructure system replacement surcharges. The Office of the Public Counsel and Spire Missouri Inc. filed timely applications for rehearing.

Section 386.500.1, RSMo 2016, states that the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission, the applications for rehearing do not demonstrate sufficient reason to rehear the matter. The Commission will deny the applications for rehearing.

THE COMMISSION ORDERS THAT:

1. The Office of the Public Counsel's Motion for Rehearing or Reconsideration is denied.

2. Spire Missouri Inc.'s Application for Rehearing is denied.
3. This order shall be effective when issued.
