# ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

)

On June 11, 2019, Missouri-American Water Company's (Missouri-American) submitted a request to change an Infrastructure System Replacement Surcharge (ISRS). On November 21, 2019, the Commission issued its *Order Approving Partial Stipulation and Agreement and Approving Infrastructure System Replacement Surcharge*, which rejected Tariff Number YW-2020-0035. The Commission authorized Missouri-American to file a new tariff reflecting the terms of the *Order*, namely that the recovery should not include net operating loss.

On November 21, 2019, Missouri-American filed a compliance tariff sheet (Tracking No. YW-2020-0087) designed to produce the appropriate revenue increase. The filed tariff sheet has an effective date of December 21, 2019. Also on November 21, 2019, Missouri-American filed a *Motion for Expedited Treatment*, requesting the proposed tariff sheet to go into effect December 7, 2019, or as soon thereafter as reasonable, rather than December 21, 2019.

Thereafter, Staff filed its expedited recommendation, which advised the Commission to approve the compliance tariff. Staff states it has no objections to the request for expedited treatment. No objections to Missouri-American's compliance tariff or its request for expedited treatment were received from any party.

Upon reviewing the pleadings, the Commission finds Missouri-American's tariff sheet complies with the Commission's November 21, 2019, *Order* and will approve it. To allow this tariff to go into effect on its filed operation of law date, the Commission will make this *Order* effective in less than 30 days, and will approve the tariff to become effective on December 21, 2019.

# THE COMMISSION ORDERS THAT:

1. The following tariff filed on November 21, 2019, by Missouri-American Water Company, and assigned Tracking No. YW-2020-0087, is approved to become effective on December 21, 2019:
