ORDER MODIFYING DUE DATES FOR THE LIST OF ISSUES AND STATEMENTS OF POSITION

Issue Date: December 13, 2019

Effective Date: December 13, 2019

On November 18, 2019,¹ the Commission issued its *Order Continuing Evidentiary Hearing and Amending Procedural Schedule*. That order set January 2, 2020, as the deadline for filing the List of Issues and January 3, 2020, as the deadline for filing Statements of Position. It set January 6 and 7, 2020, as the dates for Oral Argument and an Evidentiary Hearing.

In order to allow the Commissioners better opportunity to review the parties' filed testimony and recommendations in the context of their List of Issues and Statements of Position, the Commission will modify the procedural schedule, making the List of Issues due on Friday, December 27 and the Statements of Position due on Monday, December 30.

THE COMMISSION ORDERS THAT:

1. The procedural schedule is modified. The List of Issues (Factual and Legal) shall be filed no later than December 27, 2019, and Statements of Position shall be filed no later than December 30, 2019.

¹ All date references will be to 2019 unless otherwise indicated.

2. Otherwise, the established procedural schedule shall remain in effect.
3. This order shall be effective when issued.
