ORDER SETTING PROCEDURAL CONFERENCE

On November 27, 2019, the Missouri Industrial Energy Consumers, the Office of Public Counsel, and Midwest Energy Consumers Group (collectively "Joint Movants"), filed a motion requesting a prehearing conference. Joint Movants want a prehearing conference to determine if an evidentiary hearing is necessary, and discuss concerns about how the Accounting Authority Order (AAO) Ameren Missouri is seeking fits with its currently pending general rate case, File No. ER-2019-0335. The motion notes that the current ratemaking treatment for Callaway Energy Center operations and maintenance expenses is different from the one proposed in Ameren Missouri's request for an AAO.

Ameren Missouri filed a response asking the Commission to deny the request for a prehearing conference. In support thereof, Ameren Missouri stated that a conference call between it and the Joint Movants was scheduled for December 6, 2019.

The Commission's Staff recommendation is due on December 27, 2019, and Ameren Missouri and the Joint Movants have had ample opportunity to conduct a phone conference. The Commission is also concerned about how the AAO will coordinate with the pending rate case. Therefore, Commission finds that a prehearing conference is now

appropriate to discuss its concerns and potential solutions. The parties shall appear in person or by telephone at the conference unless excused by the regulatory law judge.

THE COMMISSION ORDERS THAT:

1. A procedural conference will be held on December 30, 2019, beginning at 9:00 a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act.
