On December 16, 2019, Evergy Missouri Metro and Evergy Missouri West (Evergy Missouri) filed an application for approval of modifications to its Technical Resource Manual (TRM). In support of its request, Evergy Missouri states that the Commission approved Evergy Missouri’s MEEIA Cycle 3 application, but did not approve the TRM submitted with its application. Evergy Missouri has revised its TRM for the Commission to reflect final EM&V results from program year 3 of MEEIA Cycle 2. Evergy Missouri asks that the revised TRM be approved to become effective January 1, 2020.

THE COMMISSION ORDERS THAT:

1. The Commission’s staff shall make a recommendation regarding approval of Evergy Missouri Metro’s and Evergy Missouri West’s revised Technical Resource Manual no later than December 20, 2019, at 10:00 a.m.
2. Any other party wanting to file comments or recommendations regarding Evergy Missouri Metro’s and Evergy Missouri West’s revised Technical Resource Manual shall do so no later than December 20, 2019, at 10:00 a.m.

3. This order shall be effective when issued.
