**ORDER DIRECTING FILING**

On December 16, 2019, Evergy Missouri Metro and Evergy Missouri West (Evergy Missouri) filed compliance tariffs as ordered by the Commission in its Report and Order. The tariffs bear an issue date of December 16, 2019 and an effective date of January 1, 2020. Section 393.140(11) RSMo requires that a tariff bear an effective date no less than 30 days from its issue date, though the Commission may for good cause shown allow the tariff to go into effect in less than thirty days.

The Commission will order Evergy Missouri to file substitute tariffs with a statutorily compliant effective date of January 15, 2020. If Evergy Missouri wants the tariffs to take effect sooner than January 15, 2020, it shall file a motion for expedited treatment. Commission Rule 20 CSR 4240-2.080(14) contains the requirements for a party to request expedited treatment.

**THE COMMISSION ORDERS THAT:**

1. Evergy Missouri Metro and Evergy Missouri West shall file tariffs in compliance with Section 393.140(11) RSMo, no later than December 18, 2019, at 10:00 a.m.

2. Any request for expedited treatment of the tariffs shall be filed no later than December 18, 2019, at 10:00 a.m.

3. This order shall be effective when issued.
