On December 13, 2019, Power On Technologies, Inc. (Power) notified the Commission that the company no longer wished to be registered as an IVoIP provider in Missouri.

The Commission granted Power registration to provide IVoIP services in the State of Missouri in File Number DA-2018-0361.

The Commission will direct its Staff to review the request and file a recommendation regarding the cancellation of Power's IVoIP registration.

### THE COMMISSION ORDERS THAT:

1. No later than January 17, 2020, the Staff of the Missouri Public Service Commission shall file a recommendation regarding Power's request to cancel its IVoIP registration.

2. This order shall be effective when issued.
