ORDER TO SHOW CAUSE

On June 24, 2024 Adhol W. Deng filed a complaint before the Missouri Public Service Commission (Commission). An Order was issued on September 25, 2024 directing that a prehearing conference be held. A prehearing conference was held on November 5, 2024 and the Complainant did not appear. The prehearing conference was attended by Spire, the Office of Public Counsel, and Staff for the Commission. Non-attendance at the prehearing conference is grounds for dismissal under 20 CSR 4240-2.110. In this instance, the Complainant failed to seek a continuance and did not appear. In order to prevent dismissal of this complaint, the Complainant must file pleadings showing why this application should not be dismissed.

At that conference, Spire requested that the case be dismissed because the Complainant failed to follow an order of the Commission to appear at the conference. This order directs the Complainant to show cause why they did not appear before November 15, 2024, or Spire’s Motion To Dismiss will be granted.

THE COMMISSION ORDERS THAT:

1. The Complainant shall file pleadings that show why this application should not be dismissed by November 15, 2024.
2. This order shall be effective when issued.
