ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On November 4, 2024, Liberty Utilities (Midstates Natural Gas) Corp d/b/a Liberty filed tariff sheets to reflect changes in the company's Purchased Gas Adjustment clause and Actual Cost Adjustment and Refund Factor. Those tariff sheets were assigned Tracking No. JG-2025-0064 and bear an effective date of December 1, 2024.

On November 5, 2024, Liberty withdrew Tracking No. JG-2025-0064 and filed new tariff sheets assigned Tracking No. JG-2025-0065. The new tariff sheets have an effective date of December 1, 2024.

The Commission will withdraw its prior order regarding the now withdrawn tariff sheets and will direct the Staff of the Public Service Commission (Staff) to file a recommendation regarding the new tariff sheets, JG-2025-0065. The Commission will also establish a deadline for any other entity to file a response to the new tariff sheets.

THE COMMISSION ORDERS THAT:

1. No later than November 14, 2024, Staff shall file a recommendation with regard to Tracking No. JG-2025-0065.
2. Any other entity wanting to comment on the tariff sheets shall do so no later than November 14, 2024.

3. The Commission's previous order directing a Staff recommendation and setting a time for comments regarding Tracking No. JG-2025-0064 is withdrawn.

4. This order shall be effective when issued.

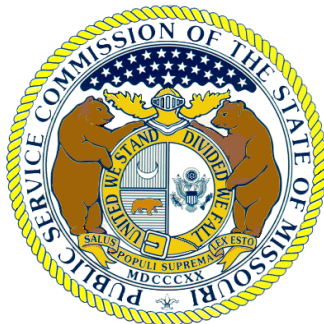
