On November 5, 2024, NRDC objected to a Non-Unanimous Stipulation and Agreement (Stipulation). The Commission will order its Staff and the signatories to the Stipulation to respond. The responses shall include suggestions for additional hearing dates in November for live testimony concerning the Stipulation, a briefing schedule, as well as other suggested resolutions to this case.

### THE COMMISSION ORDERS THAT:

1. The signatories and the Staff of the Commission to the Stipulation shall respond as ordered above no later than November 8, 2024.
2. Any other party who wishes to respond shall do so no later than November 8, 2024.
3. This order shall be effective when issued.

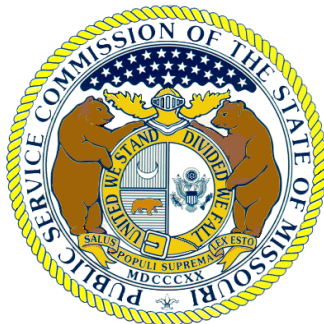
