On October 7, 2024, Complainants Trupti and Dehesh Patel filed a formal complaint with the Commission against Spire Missouri Inc. d/b/a Spire. That same day the Commission issued an order giving notice of the complaint and directing Spire to file an answer, notice of satisfaction of complaint, or request for mediation by November 6, 2024.

On November 6, 2024, Spire filed a *Notice of Satisfaction*, stating that Complainants and Spire have resolved the issues presented in the complaint and that Complainants are satisfied with the result.

Commission Rule 20 CSR 4240-2.070(8) states that a public utility against whom a complaint has been filed may, within 30 days after the date of notice of the complaint, file a notice that the matter complained of has been satisfied. The Commission, therefore, will take notice of the satisfaction of judgment.

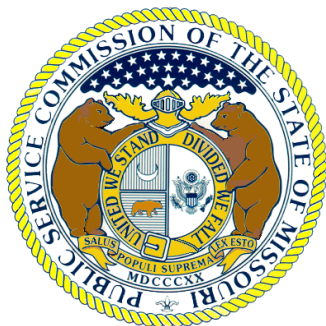
